#### **NEW CLIENTS**

In 2018 we assisted 314 new families for the first time. They needed food, clothing, or help with bills.

# **FOOD PANTRY**

Our mission is to provide food to families in need. In 2018 we served 3,463 families, distributing 242,827 pounds of food and personal hygiene items. This benefited 8,381 individuals which includes 2,722 children. A significant portion of this food is from our community partners as well as Costco, Forgotten Harvest, Waterford Panera Bread, Meijer Simply Give, White Lake Community Garden, Waterford Insurance and private gardens.

#### **EASTER MEALS**

We provided 171 families with food for a special Easter dinner including pie! A total of 4,549 pounds of food was distributed to 115 children and 296 adults.

**TOTAL VALUE: \$7,824** 

#### **BACK TO SCHOOL PROGRAM**

New back packs filled with grade appropriate school supplies, a shopping trip to Meijer for new clothing, and a Resale Store gift card were provided to 77 children, grades K-12, from 30 low income families. Throughout the month of October and September our families used vouchers in the Resale Store to purchase clothing for their children.

## **THANKSGIVING MEALS**

We provided a record number of turkeys and all the fixings for a complete holiday meal for 222 families. This fed 397 adults and 206 children. Our low income families & elderly appreciate our holiday meals.

**TOTAL VALUE: \$10,156** 

#### **CHRISTMAS / HOLIDAY MEALS**

For Christmas/Holiday meals again we fed a record number of people. 663 people including seniors, adults living alone, disabled, parents and children from 265 households were given a complete holiday meal with ham, stuffing, potatoes, gravy, vegetables, rolls, cool whip & pie!

# ADOPT A FAMILY CHRISTMAS/HOLIDAY PROGRAM

Families, churches and businesses participated in our Adopt-A-Family Program, providing gifts to 87 families with 326 people, including 161 children & 28 seniors! Thank you for helping put smiles on many children's faces this past Christmas!

**TOTAL VALUE: \$41,019** 

#### 2018 CHILD SUMMER FOOD PROGRAM

We distributed additional food in June - August 2018. Summer is a difficult time for very low income families. Instead of children receiving a free breakfast and lunch at school they are home and hungry. Families do not have additional funds for meals and snacks throughout the day. Client families with children in the household received extra bags filled with child-friendly breakfast and lunch items at each of their monthly pantry visits. This program is supported by donations, churches, scout troops & Stamp Out Hunger food drive. 125 families with 242 children received 4,709 pounds of food or 3,924 meals.

TOTAL VALUE: \$8,099

# CLOTHING & HOUSEHOLD VOUCHERS PROGRAM

Our Resale Store, open to the public, is supported by items donated from our generous community. Free clothing and household items valued at \$35,776 were given to 519 households. These items help clothe the family and provide household items to restart a home. Client Services distributed to 330 people donated items of socks, pj's, back packs, winter coats, hats etc. valued at \$9,763.

**TOTAL VALUE: \$45,539** 

#### CRISIS FUNDING

When funding is available, Open Door provides emergency funds to prevent evictions, utility shutoffs, fuel only gas cards, car repairs, medical needs, etc. 211 families were helped with \$25,082 in funds/support. In addition to funds provided directly by Open Door, we collaborate with many other church partners in securing over \$20,000 in additional funding to prevent crisis for families.


